- No direct contracts with pharmacies

 Covers most FDA-approved prescription medications




Provides patients discounts of up to 80% on their prescriptions



How Does It Work For The Patient?

Step One

Patient is prescribed medication.

Step Two

Patient compares pricing.

Step Three

Patient presents card at the pharmacy to unlock savings!

Step One

Find leads. Use the CRM and your personal network.

Step Two

Log kits using the CRM. Note, cards that are handed to individuals do not require a kit to be logged.

Step Three

Receive commission for every card activation.


Boundless Opportunity





\$10 per activation: Activations refer to the first time a patient uses a SingleCare card to fill their prescription at the pharmacy. Remember, each unique individual who uses the card counts as a new activation



Plus: Bonus incentives are offered on a monthly basis

Account will be created when you are due to receive payment for the first time




Choose either direct deposit or mailed check




Payments are made on or around the 15th of each month for previous month activity

Monthly Incentives


